ERIE COUNTY SPORTSMEN'S LEAGUE RANGE RULES

1. Shooting hours are 10:00 A.M-8:00 P.M. Daylight Saving Time (Approx. March-November) and 10:00 A.M. - 5:00 P.M. Standard Time (Approx. November-March).
2. **MEMBERS ONLY:** A member may be accompanied by no more than two guests per visit. Guests who wish to visit more than three times per year must become a paid member.
3. All members must always present a current membership while on E.C.S.L. property, and members may be asked to show their ID.
4. The use of alcohol or drugs is prohibited during or before participating in any shooting activity. Anyone using alcohol or drugs is prohibited from participation in any shooting activity for the remainder of that day.
5. **EYE AND EAR PROTECTION IS REQUIRED ON ALL RANGES:** Eye and ear protection is not optional and shall be worn by participants and spectators while in the vicinity of all shooting activities.
6. **Be considerate of other shooters and guests.**
7. A parent or responsible adult must accompany Junior Members under 18 years old.
8. All targets must be placed so the bullet will go directly into the backstop to prevent ricochets. **DO NOT SHOOT AT TARGET STANDS.**
9. No shooting at unauthorized targets such as cans, bottles, boxes, exc. Members are responsible for cleanup of their shooting area (including all targets and balloons). It is prohibited to move target stands from range to range, target stands must remain on the range that they are placed.
10. **Ground Targets and/or Tannerite are PROHIBITED.**
11. **FULL AUTO AND 50 B.M.G. PROHIBITED.**
12. **All Centerfire Rifle Shooting may only be done from the benches on either of the rifle ranges. The use of these rifles in any of the pistol pits is PROHIBITED. (Rimfire Rifles and Shotguns are permitted to be used in the pistol pits.)**
13. **NO UNSUPERVISED RAPID FIRE. ALL SHOTS MUST BE AIMED.**
14. **NO HANDLING OF FIREARMS WHILE PEOPLE ARE DOWN RANGE.**
15. **STEEL IN PISTOL PITS ARE FOR HANDGUN CALIBERS ONLY.**
16. Obey all commands from range officers and volunteers, including all posted range signs.
17. All gates are to be closed when finished using the property.
18. All rules are enforced on E.C.S.L. ranges. Violations will result in suspension of club privileges.
19. Please retain the copy sent with membership card.

PLEASE NOTE: Since Erie County Sportsmen's League is not just a rifle, pistol, or trap shooting facility, some or all of the ranges may need to be closed during a scheduled **CLUB EVENT OR WORKDAY** for maintenance or safety reasons. Please check with one of the club officers or our website if you have any questions.
